
AFTERCARE

Weekly aftercare is provided by the YMCA on the St. Charles Borromeo School campus and is available until 6pm daily during regular school days. The weekly cost is \$42 per student.

IMPORTANT INFORMATION

FACTS Tuition Management: All families are required to register for electronic tuition payments through FACTS. If a payment is returned, a \$30 fee will be charged. In order to qualify for a 12 month payment plan, the first payment must be made by July 31, 2018.

Due Dates: Monthly tuition is paid on either the 5th or 20th of the month. Tuition must be paid in full by June 30, 2019. 8th Grade students must have tuition paid in full by May 31, 2019. All financial obligations must be met prior to release of report cards or transcripts.
