KINDERGARTEN – 8TH GRADE

FEES

NEW FAMILY APPLICATION FEE - \$100 one-time fee per family

REGISTRATION FEE - \$275 annual fee per student

Fees are non-refundable and due at time of registration to secure a space for your student(s).

8th GRADE GRADUATION FEE - \$250 one-time fee per student

Fees will be charged to FACTS and paid based upon the payment plan selected by the family.

TUITION

CATHOLIC RATE

Parishioners of any Catholic Church located within the Diocese of Orlando are eligible for a tuition discount of up to \$2,375 off of the General Community Rate. An approved Pastor Permission Form must be remitted to the school finance office if their parish is not St. Charles Borromeo.

**SIBLING DISCOUNT: A multiple student discount may apply to the tuition remaining after any scholarships have been deducted. The award of a sibling discount is at the discretion of the Pastor and school administration and is up to the amount listed per family.

PRESCHOOL

FEES (not applicable to VPK only students)

TUITION

PRE-K 4 YEAR OLD PROGRAM – VPK (4 years old by September 1st)

- Parents must obtain a VPK voucher from the Early Learning Coalition of Orange County
- Voucher covers the cost of tuition for 8:30 am to 11:30 am only
- Parents are responsible for the cost of uniforms (available for purchase in the front office)
- Students may not be dropped off prior to 8:20 am if they are enrolled in VPK hours only

AFTERCARE

Aftercare is provided by Champions Aftercare PreK – 8th grade on the St. Charles Borromeo Catholic School campus and is available until 6pm daily during regular school days. Champions has multiple pricing tiers ranging from \$23 for 1-2 day up to \$53 for full time and offers a multi student discount.

IMPORTANT INFORMATION

FACTS Tuition Management: All families, except those that are VPK hours only, are required to register for electronic tuition payments through FACTS. In order to register for a 12 month payment plan, the first payment must be made by July 31, 2019.

If a payment is returned, a \$30 fee will be charged by FACTS. **Due Dates:** Monthly tuition is paid on either the 5th or 20th of the month. Tuition must be paid in full by June 30, 2020.
