FEES

NEW FAMILY APPLICATION FEE - \$100 one-time fee per family

FACTS MANAGEMENT FEE - \$25.00 per student

REGISTRATION FEE - \$275 annual fee per student, plus \$10 fee charged by FACTS

SECURITY FEE - \$100 per student

All fees are non-refundable

8th GRADE GRADUATION FEE - \$350 one-time fee per student

Fees will be charged to FACTS and paid based upon the payment plan selected by the family.

TUITION

ACTIVE CATHOLIC PARISHIONER RATE*

**Active parishioners are registered at a Catholic parish and are regularly participating in the life of the parish. (For example, submitting envelopes during the collection at Mass, even if they're empty, shows that you are attending Mass and participating as a parishioner.)*

Please be aware that "registration" does not mean "participation."

Parishioners of any Catholic Church located within the Diocese of Orlando are eligible for a tuition discount off of the General Community Rate as long as an approved Pastor Permission Form has been submitted to the school finance office, if their parish is not St. Charles Borromeo.

FEES (not applicable to VPK only students)

NEW FAMILY APPLICATION FEE - \$100 one-time fee per family, plus \$25 fee charged by FACTS

REGISTRATION FEE - \$175 fee per student, plus \$10 fee charged by FACTS

All fees are non-refundable

TUITION

PRE-K 4 YEAR OLD PROGRAM – VPK (4 years old by September 1st)

- Parents must obtain a VPK voucher from the Early Learning Coalition of Orange County.
- Voucher covers the cost of tuition for 8:30 am to 11:30 am only.
- Parents are responsible for the cost of uniforms (available for purchase in the front office).
- Students may not be dropped off prior to 8:20 am if they are enrolled in VPK hours only.

IMPORTANT INFORMATION

FACTS Tuition Management: All families are required to register for electronic tuition payments through FACTS. In order to register for a 12-month payment plan, the first payment must be made by July 31, 2026.

If a payment is returned, a \$30 fee will be charged by FACTS.

Due Dates: Monthly tuition is paid on either the 5th or 20th of the month.

Tuition must be paid in full by June 30, 2027.

AFTERCARE

Aftercare is provided on the St. Charles Borromeo School campus and is available until 6:00 pm daily during regular school days. (Separate fee applies.)
